



Pathfinders Trials Motorcycle Club (Inc) 2019 Club Events - SUPPLEMENTARY REGULATIONS

1. INDEMNITY

Motorcycle sport can be dangerous, and by taking part in any Pathfinders Trials MCC event, you are voluntarily participating in an event which involves risk.

Your machinery or equipment may be damaged or destroyed.

You may be injured, maimed or killed.

Motorcycle sport does have inherent risks, and every one of us has a part to play in managing that risk down to an acceptable level.

Part of your responsibility as competitors is follow directions given to you by our officials.

By entering an event and signing the indemnity, you have affected your legal rights and obligations.

<u>DO NOT sign the entry sheet or indemnity unless you are completely satisfied that you understand the content and agree to be bound by them.</u>

2. ANNOUNCEMENT

Pathfinders Trials MCC will be conducting a number of events during the 2019 Season from March to November.

3. JURISDICTION

These events will be conducted in accordance with the 2019 MoM 19.11.3.2 Trial, these supplementary regulations and any further instructions issued on the event day at the rider briefing by the Clerk of Course and / or Organiser.

All competitors including minders must hold current MA National licences, Juniors wishing to compete in the Junior class must be under the age of 16 years on the day of the event, Veterans must be 40 years of age or older on the day of the event.

One Event Licences will be available at each event.

Overseas riders wishing to compete in the event must purchase a MA National Licence, produce authorisation and obtain the relevant clearance from their FMN, they are to also provide their own repatriation insurance if required. Pathfinders Trials MCC reserves the right to alter the event to suit entries and or conditions with the approval of the MASteward.

In addition the following rules will apply:

Persistent, intentional gardening by riders or minders may result in exclusion from the event. It is part of Pathfinders Trials MCC Risk Management Strategy and part of our Duty of Care to you the Competitor, that you are NOT permitted to ride the course alone. You must ride the course with another Competitor or a Minder at all times.

On some occasions, Observers will not be available for all Sections. Competitors are NOT permitted to score themselves or their individual scorecards. The Competitor who is riding the course with you will score your ride in each section and mark your scorecard.

4. PERMIT (Please check 2019 calendar dates for Permit types):

All events will be conducted under an MA Permit.

Entry to events run as a Coaching event, Practice event or Closed to Club event are for Pathfinders Trials MCC members only.

Entry to events run as an InterClub events are for members of MWA or RCB affiliated clubs only.

Entry to events run as an Open event are for all entrants holding a valid MA licence.

5. KEY OFFICIALS

Officials for each event will be announced at the event and may include a MA Steward, Clerk of Course, Race Secretary and Scrutineer.

6. INSURANCE

Competitors and Minders must familiarise themselves with 2019 MoM's National Personal Accident Insurance. Further information regarding insurance can be obtained from Motorcycling Australia. Overseas riders wishing to compete in the event must purchase a MA National Licence, produce authorisation and obtain the relevant clearance from their FMN, they are to also provide their own repatriation insurance if required.

7. ENTRIES

Entry by electronic means will be available during the season (check the Club website).

All Competitors must present Club Membership and MA Licence to Race Secretary and sign on at the point of entry.

Late entries or "Walk up" entries on the day of the event may be accepted at the discretion of the Race Secretary.

All competitors can enter one class only.

Juniors wishing to compete in a class other than junior may do so with the approval of the Clerk of Course.

8. FEES (Subject to change)

One Day Events

Solo \$25.00

Junior \$15.00

Sidecar \$40.00

Two Day Events

Solo \$30.00

Junior \$20.00

Sidecar \$45.00

- 9. MACHINES must comply with Chapter 18 of the 2019 Manual of Motorcycle Sport. Sound Control testing will take place at each event.
- 10. MACHINE EXAMINATION Competitors and Minders are to present themselves with their machines, licences and riding apparel for competition to machine examination.

Self MACHINE EXAMINATION may be conducted at any event. Random bike checks will be conducted at any time of the event by the MACHINE EXAMINATOR.

Competitors must report to machine examination no later than 9.15 a.m.

11. HELMETS AND CLOTHING

Helmets and Protective Clothing must be in a good condition and comply with 2019 MoMs Appendix A.

Covered footwear is compulsory in the pits (if pits are provided).

12. CHANGE OF MACHINE

A change of machine is permitted on the condition that notification is presented to the Clerk of the Course prior to the substitution and further, that the replacement machine must have been correctly entered, examined and passed at machine examination.

13. EVENT TIMES (Subject to change)

Machine Examination 8 a.m. - 9.15 a.m.

Officials Briefing 9.10 a.m.

Riders Briefing 9.15 a.m.

Start 9.30 a.m.

Finish – to be advised and is at the Clerk of Course / Organisers discretion.

14. COURSE

The number of sections and laps will be announced at the riders briefing.

The severity of sections will vary within an event, and from event to event. Your responsibility is to ride only those sections that you are capable of completing safely.

A nominated warm up area may be provided at certain venues.

15. FIRST AID

It is a condition of entry that First Aid must be accepted wherever deemed necessary by the attending first aiders. The Steward has the right to refuse further participation in the event of a rider if first aide requirements are not adhered to.

15.1. Injuries

Riders transported to hospital must obtain a medical clearance which is to be supplied to MWA and may be demanded at the next Trial event.

15.2. Ambulance Cover

All riders are reminded that ambulance cover is compulsory as a condition of your licence. Cover must be maintained for the duration of your licence.

16. TIES

In the event of ties they will be resolved as per 2019 MoM 19.11.1.3

17. PROTESTS

Protests and appeals are to be dealt with according to 2019 MoM 7.2.1

Summer Series is run over 4 events. Top 3 event scores are counted for awards. A minimum of 3 Summer Series events must be completed for awards.

Prestige Series is run over 6 events. Top 5 event scores are counted for awards. A minimum of 3 Prestige Series events must be completed for awards.

Awards and / or trophies will only be made to Pathfinders Trials MCC members - ie Full or Family members of the Pathfinders Trials MCC.

19. DRUGS AND INTOXICANTS

Pathfinders Trials MCC has adopted the Australian Sports Commission Doping Policy as outlined in the 2019 MoMs. Drug testing may occur at any Pathfinders event or at any MWA sanctioned event.

20. CODE OF CONDUCT

Pathfinders Trials MCC has adopted the Member Protection Policy as per 2019 MoMs. Competitors and Officials must make themselves aware of their obligations under this policy.
